We had a strong Management Committee that contributed numerous novel concepts.




We had a strong membership year with 687 processed memberships across 13 districts (see (A)).

National Show 2022

Discussion was held about 2022 National Show. The best time for this would be after September and before NRA Finals (end October).

ACTION REQUIRED - New Board to organise.

State Show 2022

Discussion was held about State Shows. As previously decided, State Shows are not yet to be held as NBHA Australia are not currently big enough to sustain two big shows per year.

Having said that, there is nothing to stop Districts funding and organising their own SUPER SHOWS (with BUCKLES/PRIZES and potentially WILD CARDS) similar to what Katie Vaughan organised at Dallarnil in 2020.

General Business

In line with international rules, the two age classes for Juniors (YOUTH = 12 years and under & TEEN = 13 years to 18 years) must be abide by going forward. This means that there will no longer be Peewees, as they fall into YOUTH. Led is a feature event that Districts may still choose to run at their discretion.

Membership for Youth or Teen = \$50 for year, Open or Senior = \$100. Day membership = \$20, Associate = \$20, Led only (12 years and under) = \$20.

Feature events (Led / Poles / Beginners / Futurity / Derby) are to be run at the discretion of the District and the rules can be taken out of the By-Laws. Districts run these as they see fit, however the rules must be approved by NBHA Australia (for consistency across Districts).

As per <u>Section B - Show Sanctioning</u> (International Rules)

- 1. There will be four classes of competition as follows (Proof of age may be required at the discretion of Show Management):
- o Open
- o Youth (12 years of age and under as of January 1st of the competition year)
- o Teen (13-18 years of age and under as of January 1st of the competition year)
- o Senior (50 years of age age and over as of the date of the show)
- a. Show Management may allow eligible contestants to rollover/carryover their time in the Open class for the Youth, Teen or Senior class. Contestants wishing to rollover a time must declare their intent before event begins. Any contestant carrying time must pay the applicable entry fee for both classes and is eligible to win prize money and NBHA points just as if the time was run in the other class. If this is done, the Open must be run first. The pattern for the Open, Youth, Teen and Senior must be exactly the same and must not be changed in any manner.
- b. The NBHA points, and payout, if any, will be determined based only on those riders who qualify for that particular class (Youth, Teen or Seniors).

The By-Laws / Constitution & District Director Handbook should be updated to be in line with the International Rules and feature events removed (as these are the responsibility of the Districts) before the 2022 season kick-off (1 January 2022).
