- Ensure the club is run according to its Constitution, Official NBHA Rulebook, By-laws, District Directors Handbook, purpose, policies and procedures
- Coordinate the planning of activities in a manner which ensures the aims and objectives of the club are fulfilled
- · Carry out the recommendations of members as expressed at the annual general meeting
- Provide members with detailed information regarding the running of the club
- Monitor the performance of the club officials (according to their job descriptions) to see they are carrying out their functions. Also, it monitors the performance of any sub-committees or affiliates.
- Ensure that all committee members are well-versed in past activities and the reasons for previous decisions, making sure any deviations from these are fully considered.
- Planning and budgeting for the future
- Ensure that all members of the committee are role models in the area of leadership.

Secretary

The Secretary is the chief administration officer of the organisation. This person provides the coordinating link between members, the management committee and outside agencies.

Responsibilities and Duties

- Contact person for Association.
- Record and deal with all correspondence.
- Arrange meetings (Committee, Special & AGM), prepare agendas and record minutes.
- Maintain membership list and provide updates to District Directors.
- Receive and respond to sanction forms/calendar updates and send to Publicity officer for inclusion on website.
- Prepare and receive requests for transfers and send to District Directors.
- Maintain a list of upcoming competitions & events.
- Forward information of events to Publicity Officer and distribute District Directors.
- Co-ordinate with District Directors to accept entries for National and State events/activities.
- Ensure entries for National and State events meet closing dates.
- Maintain sufficient copies of all required forms.
- Ensure all members have access to other relevant reading material.
- Prepare annual report for AGM.

- District Bank accounts and approving payments.
 Districts need independence and not have to rely on approval from NBHA Australia for payments.
 This means they need to be independent entities.
- District Directors running Districts without input from District Members
 District Members want more say in how their Districts are run and where their money goes.
- Informal or Frivolous Complaints
 First point of call for any issues, needs to be the District. Only serious issues should come to NBHA Australia.

SET UP OF DISTRICTS (AS INDIVIDUAL ENTITIES FOR DISTRICT PRIZES) VS NBHA AUSTRALIA MEMBERSHIP

LEGISLATION CHANGES

Blue Card (or equivalent depending on State)

Industries requiring a blue card to work or volunteer with children | Your rights, crime and the law | Queensland Government (www.qld.gov.au)

Sporting and fitness

Anyone working or volunteering with children under 18 years of age in activities regulated by the blue card system must have a blue card. This includes various activities such as sport and recreation, clubs, associations, private coaching or health services.

There are many roles within the fitness industry and whether you will need a blue card will depend on the nature of the work you do. An exemption may apply if a parent volunteers in an activity their child participates in (e.g. a mother volunteering to coach her child's netball team), however there are a number of scenarios which can apply in the sporting industry. You cannot access an exemption or volunteer within this context if you are a restricted person.

Parents who are thinking of volunteering at a sporting club should speak directly to the club/executive body to confirm if an exemption applies to their situation.

Implementation of Director ID

If a person wants to become or is a director of a company registered with ASIC or the Office of the Registrar of Indigenous Corporations (ORIC), they are

- required by law to apply for a director ID.
- Directors appointed on or before 31 October 2021, have until 30 November 2022 to apply.
- New directors must apply prior to their appointment.
- ABRS is responsible for delivering the director ID service and is part of the Australian Taxation Office (ATO). ASIC is responsible for enforcing related offences.
- It's a criminal offence if directors do not apply on time and penalties may apply.

Natural Justice

The key elements to natural justice are as follows:

- 1. That the person charged with the offence has the right to know what they have allegedly done. To comply with this obligation it is necessary for not only the rule which has been breached to be quoted, but also the person is entitled to know the particulars of what they allegedly have done.
- 2. The tribunal must not be biased. This is often where natural justice fails in that the tribunal is biased. Often some excuse is used to justify persons who have prejudged the matter sitting in the determination of the matter.
- 3. The person is entitled to be heard in their own defence. A reasonable opportunity needs to be given to the person and where there is a reasonable explanation adjournments should be given to fully allow a person the opportunity to be heard.

There are a couple of other issue which are not strictly principles of natural justice, but lead to the provision of natural justice.

- 1. The right of the person charged to receive all of the material which has been provided to the tribunal in sufficient time to enable them to consider the material to enable appropriate submissions to be made and potentially conflicting evidence to be provided.
- 2. It is often considered that the right to be legally represented is a right of natural justice. That is not the case. Often rules of organisations in fact strictly prohibit the right to be legally represented before the tribunal. Tribunals should act fairly in that regard in all of the circumstances and consider the ability of the person to represent themselves, particularly in matter which has serious consequences. I think careful consideration needs to be given as to whether a person should be allowed to be represented by competent counsel.
- 3. There is a requirement to reach a reasoned and unbiased decision. Unless the rules of the organisation provide, there is no strict obligation for the tribunal to provide reasons.
- 4. The final matter is a requirement that if there are rights of appeal from the tribunal, that the respondent is notified of those appeal rights.

What is Natural Justice? - Play by the Rules - Making Sport inclusive, safe and fair

OUTCOME: UPDATE TO NBHA CONSTITUTION AND BY-LAWS

Complaints that relate to a District, or District Director, are forwarded directly to them to analyse and deal with the complaint. NBHA Australia will only deal with issues relating to NBHA Membership.



Protests and Complaints

Persons who believe a rule violation or infraction has occurred at an NBHA event, may file a written protest with NBHA Australia, enquiries@nbha.com.au.. The written protest must be accompanied by a \$50 protest fee. The protest must be made within 30 days of the incident which is being protested. If the protest proves to be valid, the \$50 protest fee will be returned to the person filing the protest. If the protest proves to be invalid, the protest fee will be returned to the district where the protest was filed to be used for district year end awards. In certain cases, determined by the Executive Director, NBHA Headquarters may reserve the right to return the \$50 protest fee even if the protest proves to be invalid.

This is the ONLY manner in which a protest or complaint will be accepted.

NOTE: This rule does not prevent Directors and Show Managers from correcting obvious problems brought to their attention, without the submission of a written protest fee. Any situation not covered under these rules shall be decided by the NBHA official on site.

Informal Complaints / District Grievances

District Members are encouraged to provide feedback and complaints directly to your District Directors so that they know when there is a problem and will be given the opportunity to resolve it. If informal complaints are received by NBHA Australia (i.e. without the \$50 protest fee), they will be passed back to the District Director to handle.

District Directors must:

- STEP 1 Listen to the complaint. Thank the member for bringing the matter to your attention. Apologise and accept ownership, don't blame others and remain courteous.
- STEP 2 Record details of the complaint (and email to Enquiries@nbha.com.au for information). Go through the complaint in detail so you can understand exactly what the problem is. Keep records of all complaints in one central place or register. This will help you identify any trends or issues.
- STEP 3 Get all the facts. Check that you have understood and recorded the details of the complaint correctly. Ask questions if necessary.
- STEP 4 Discuss options for fixing the problem. Ask the member what response they are seeking; it could be a refund or apology or working together to run events better in the future. Decide if the request is reasonable.
- STEP 5 Act quickly. Aim to resolve the complaint quickly. If you take a long time they tend to escalate.
- STEP 6 Keep your promises. Keep the member informed if there are any delays in resolving their request. Don't promise things that you can't deliver.
- STEP 7 Follow up. Contact the member to find out if they were satisfied with how their complaint was handled. Let them know what you are doing to avoid the problem in the future
